

# Next Generation Judo Ltd Terms and Conditions

## **Definition**

Activity – means any Club, Course, Event or Activity organised and operated through any member of Next Generation Judo Ltd (**NGJ Ltd**)

Terms and Conditions – means the terms contained in this document and any other document referred to within it.

## **Bookings**

By booking a place on any Activity these are the Terms and Conditions.

NGJ Ltd offers an online booking service, once the booking form has been completed and submitted, payment in full is required by your chosen method on or before the activity is due to take place. Bookings are subject to these Terms and Conditions.

For safety reasons we can only guarantee a place on ANY activity to those booking in advance. Those that arrive on the day will not be guaranteed a place on the activity.

## **Promotions**

Next Generation Judo Ltd from time to time offers promotions. In the event that you have been issued with a promotional code this code must be redeemed and used in accordance with both the terms and conditions of that promotion and these Terms and Conditions.

## **Refund Policy**

Payment for any activity is non-refundable or transferable.

The parents/ guardians of children who consistently misbehave will be notified and asked to take action to prevent a recurrence. If the misbehaviour continues NGJ Ltd reserves the right to exclude misbehaved children from any activity/ event without a refund.

## **Cancellations**

If the event we have to cancel an activity, every effort will be made to make up for any missing activities.

Where an activity cannot be made up within the payment duration, an extra activity will be put on in its place the following term.

## **Payment**

Next Generation Judo Ltd accepts; bank transfer, cheques and cash.

## **Marketing**

Due to the nature of our business, from time to time we will need to contact you to update you with times, dates, events etc. NGJ Ltd will not send unnecessary emails or text messages to you and your information will not be given to any 3rd party. By submitting a form, you are giving your consent for NGJ Ltd to make contact when it is necessary.

## **Leaving, waiting lists and transferring**

If a member wishes to leave you must notify NGJ and email: [nathan@nxtgenjudo.com](mailto:nathan@nxtgenjudo.com) or we have the right to actively seek 1 terms (5 weeks) payment as the members place can be offered to another. If a member leaves without notice and payment is owed, a letter and /or email will be sent requesting fees that are due.

This payment must be received within 14 days, if no payment is received further action may be taken.

If you would like to transfer to another activity, please notify us and all fees will be transferred. However, this is subject to availability. Failing availability, members will be placed on a waiting list.

## **Child Protection**

All Next Generation Judo Ltd staff hold current child protection and DBS certification. In the event that a child makes a disclosure or a member of staff believes that the child is suffering from abuse, we will act in accordance with our child protection policy, a copy of which is available on request.

## **Film/Photography**

Next Generation Judo Ltd may from time to time take photographs/film of any NGJ Ltd Activity. The use of this data is solely for the purpose of promoting and publicising Next Generation Judo Ltd Activities through literature, website, social media (Facebook and Instagram). Parents/guardians that do not wish for their child to be photographed/filmed must make Next Generation Judo Ltd aware of this at the time of booking or in writing before the activity starts.

## **Personal Property**

Next Generation Judo Ltd cannot be held responsible for any loss or damage to any personal belongings whilst attending an NGJ Ltd activity. Please ensure that no valuables are left unattended by yourselves or child(ren).

## **Health & Safety**

A full risk assessment will be carried out before any activity takes place at a new venue. Next Generation Judo Ltd staff hold a current emergency aid certificate issued by an appropriate body.

By agreeing to these terms and conditions you are providing consent for Next Generation Judo Ltd staff to administer any and all necessary first aid to your child as required at any time.

For safety reasons it is compulsory for all member to wear appropriate clothing at all times. T-shirts and shorts are not deemed appropriate. Appropriate clothing: Judo suit or long sleeved top and tracksuit bottoms. Next Generation Judo Ltd reserves the right to refuse permission to participate for anyone not wearing appropriate clothing. It is the parent/guardian's responsibility to ensure appropriate clothing is worn and/or available for their child for the activity being undertaken.

## **Personal Hygiene**

All members are responsible for their own hygiene.

- Finger/toe nails must be kept short.
- Appropriate clothing for activity is clean and rip free.
- Free from body odour.
- Long hair is tied back using metal free fasteners.

## **Medication and Illness**

Whilst it is recognised that some children require special creams, tablets, medicines or other types of medication such as injections and inhalers, it is our policy not to administer any form of medication.

Details of medical conditions must be included on the joining form in case of emergency.

If your child becomes ill during an activity you will be contacted by telephone call. Please ensure correct contact details are given on the joining form in case of emergency.

## **Medical information**

Any medical conditions that the participant(s) may have must be fully disclosed (1) at the time of booking in writing to Next Generation Judo Ltd and (2) to the lead coach on the Activity or at the venue.

## **Liability**

Next Generation Judo Ltd has Public Liability Insurance provided by British Judo Association (BJA).

## **Leaving an Activity**

Any child that is collected must be collected by a parent or guardian. If a child is to go home with somebody else, written confirmation must be given to [nathan@nxtgenjudo.com](mailto:nathan@nxtgenjudo.com). Any child that normally walks home unaccompanied from any Activity will only be allowed to leave unaccompanied if a parent or guardian has provided written consent prior to the commencement of the Activity.

## **Complaints**

In the unlikely event that you or your child are dissatisfied with the service we provide then please in the first instance raise it with the coach at the Activity. He/she will deal with the problem in accordance with our policies and procedures.

If the problem is not resolved to your satisfaction then please write to us within 7 days of attendance on the Activity.

We take your views and complaints very seriously and will endeavour to resolve your complaint as quickly as possible. Refunds will only be issued if Next Generation Judo Ltd is proven to be in breach of these Terms & Conditions.

## **Information**

The information on the NGJ website is updated regularly. However, we hereby exclude any warranties (whether expressed or implied) as to the quality, accuracy, efficacy, completeness, performance, and fitness for a particular purpose on this website.

These Terms and Conditions form the entire agreement between you and Next Generation Judo Ltd.

By booking an Activity with Next Generation Judo Ltd you are acknowledging your full acceptance of these Terms and Conditions and confirm that you have not relied on any other representation other than those contained within these Terms and Conditions.

If any term within these Terms and Conditions is found to be unenforceable by a competent Court then such term shall be struck out but the remaining terms within these Terms and Conditions shall continue in force to the full extent permitted by law.

These Terms and Conditions are governed by English law and subject to the exclusive jurisdiction of the Courts of England
